Pursuant to the Regulation 30 of the SEBI Listing Regulations, we would like to inform that in accordance with the SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 (hereinafter referred to as “Master Circular”), specifying Standard Operating Procedure for imposing fines and suspension of trading in case of non-compliance with the Listing Regulations National Stock Exchange Limited (NSE) has imposed a fine of Rs. 98,000 (Rupees Ninety Eight Thousand only) plus Taxes on the Company stating that the Company has not complied/delayed complied with Regulation 34 of the SEBI Listing Regulation(s) vide email and letter dated on October 30, 2023 at 7:21 PM.

The Company has replied to the email and letter on October 31, 2023 at 10:40 AM sighting the detailed reasons for non-compliance/delayed compliance and highlighted waivers granted to the Company as per approved resolution plan vide Hon’ble NCLT order dated April 21, 2022 for non/delayed compliance stated hereinabove and has also denied the applicability of the penalty and payment thereof.

The Company remains committed to ensure optimum compliances of all applicable provisions, laws, rules, regulations etc.
